- I. Call to Order – Salute to the Flag
- II. Approval of July 2010 minutes – The minutes were corrected and approved, motion by Phil Jones, seconded by Kay Guadagno.
- III. Chair's Report: Carolyn dispensed with the report as a result of the full schedule.
- IV. Treasurer's Report – Phil reported that he would be in touch with Louise, and Charles Brown indicated a current balance of \$1577.05. Mr. Brown also noted that as of Oct. 1, 2010, the County Financial Advisor will ask for an accounting of all funds not already allocated. Any unexpended funds are not carried over to the next fiscal year.
- V. Core Team Reports
  - A. Youth Awareness – Linda spoke on the committee's plans to create school Human Relations Commissions, receiving a good response from meetings at Howell and Red Bank, and five more meetings are scheduled. Plans for the second cyberbullying workshop to be held on Oct. 22 are underway with the next meeting taking place on Sept. 16, 2010, at 5PM at the Shrewsbury Presbyterian Church.

  - A. Membership: candidates – Janice was not present, and no report was made.
  - B. Communications-
    1. Web page problem re Mon. Co.- John Schwebel described his inability to change the MCHRC Web site since July; he has not received an update as to the current status. A brief discussion was held on the prospect of developing and maintaining a separate webpage, but no decision was reached, awaiting information from the County Administrator. Charles Brown provided an update later in the meeting that, due to changes made for security reasons, the platform was changed. Also he added that the Public Information Officer will require review of all materials before placing them on the Web site. John and the MCHRC are not longer able to place materials directly on our site. Carolyn will contact the county administrator to clarify

the situation. Linda moved to have John investigate and to report back in October as to how to enable us to establish a presence on the web in the most effective way and this motion was approved.

2. Social media- Randy Thompson's suggestion that we embrace social media, perhaps maintaining a presence on Facebook and Twitter was briefly discussed and will be further examined at the October meeting.

She a proposed agenda for an upcoming workshop for the MCHRC to consider called "Project ID & 287(g)." She explained some of the problems associated with the implementation of 287g and other issues related to undocumented immigrants. She is asking that some of the recipients come to a future meeting to explain the implications of 287g in Monmouth County. #### VIII. New Business

- A. Cynthia Scott, Sheriff's Office re 287(g) spoke on this program which has been in place since March 2010. To date there are five officers which have been trained to work at the Monmouth County jail, coordinating their activities with federal officials from ICE in Newark. State mandates are also being followed, and data on the program and its administration within Monmouth County is presently being collected. Undersheriff Scott answered members' questions after her presentation. Det.D'Amico clarified that only the sheriff's officers, not local police officers, are allowed to follow 287(g) procedures.
- B. Immigration and human trafficking Programs- Carolyn mentioned that Dale Daniels asked her to announce of two programs sponsored by the Holocaust, Genocide, Human Rights and Education Center, "Immigration: Fact and Fiction," November 8, 2010, and "Bought, Sold,

and Smuggled: Human Trafficking in New Jersey,” on Dec. 6, 2010. The Executive Committee agreed to co-sponsor and to help publicize these events.

- C. Monmouth County Fair 2011- Linda has written to the Prosecutor’s Office to ask to develop a partnership with them, so as to have our own table at the 2011 Fair and is awaiting a response.
- D. Latino American Assoc. Banquet 10/29/10 at Branches, Long Branch – Carmen Flores and others will be honored. The Executive Committee is asking for members to participate and will repeat their request at the October meeting.
- E. Dave D’Amico asked to publicize the Fugitive Safe Surrender program, to be held on Nov. 3-6, 2010, from 9- 4PM, at the First Baptist Church of Lincoln Gardens, 711 Somerset Street, Somerset, NJ. ## **PROJECT ID & 287(G) EVENT PROPOSAL**

### **DESCRIPTION:**

Monmouth County is in need of better forms of Identification for the most vulnerable, its immigrants. In response, we will host a round-table forum on the 287(g) law and the impact it is causing on this community. The issues for discussion are the current climate of 287(g) enforcement and the domino effect it is causing –a drain in economic system subdivision of welfare.

### **OVERVIEW:**

The current law in Monmouth County, 287(g) allows the federal government to deputize our local officials to enforce deferral immigration law. In our agency, Nosotros/Center for Immigrant Services, we offer consultation to numerous cases in which parents of not one, but three to five American children, face deportation for minor local offences which have then been taken in the hands of ICE.

According to a briefing issued by the Migration Policy Institute, 58% of detainees held on January 25, 2009 did not have criminal convictions. Furthermore, a report entitled, “The Impact of Immigration Enforcement on Child Welfare”, approximately 5.5 million children in the United States with at least one undocumented parent are likely to enter the child welfare system when a parent is detained or deported.

These statistics demonstrate that the cases our agency, (Nosotros/CIS) handles are issues faced at-large.

### **TARGET ATTENDEES:**

Diverse spectrum of community members from Political, Educational, Medical, and Faith sectors that have direct impact with the 287(g) law and with those who can help improve the current situation.

### **THE OBJECTIVE:**

By targeting the 287(g) of the Immigration and Nationality Act and explaining its implication on the Child Welfare System, we hope to instill a greater common understanding on a contemporary and urgent issue to resolve. Through local ordinance, we must create a prevention initiative that will distinguish law-abiding undocumented immigrants from criminals and that will decrease the projected drain in our welfare system in the near future.

### **THE GOALS:**

- To address the implementation of the 287(g) law and the need to understand the interpretation
- Clarify ambiguous areas of the law
- Create open communication between review board and law

### **THE SOLUTION:**

The result of this discussion is to introduce the attendees to a measure of amelioration that can be applied now. With the support of the attendees, we hope to commence the discussed prevention initiative as well as a Nosotros/CIS-issued identification program, endorsed by the county.

### **BENEFITS:**

- Distinguish law-abiding immigrants from criminals with a county-wide identification program, thus creating secure communities.
- Prevent the unnecessary drain in economic system, saving tax-payers from unwarranted tax hikes.
